Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Safeguard Installation	Caught between moving parts, Struck by flying objects	4A	<ul style="list-style-type: none"> - Conduct a pre-start safety briefing with all workers to highlight potential hazards and control measures specific to the task. - Ensure all machinery is properly serviced and maintained as per the manufacturer's guidelines to prevent mechanical failures. - Install equipment with appropriate guards and barriers to minimise exposure to moving parts. - Implement exclusion zones marked clearly around areas where reinforcement bending operations are being conducted. - Require all personnel involved in the operation to wear appropriate personal protective equipment (PPE), including safety glasses, gloves, and hard hats. - Use engineered controls such as machine interlocks and dead man switches to improve operational safety. - Develop and enforce a lockout/tagout procedure for maintenance or when clearing jams during operations. - Establish communication protocols amongst team members using hand signals or radios to ensure coordinated movement around machinery. - Secure all reinforcing bars before bending operations commence to prevent unexpected movement and release. - Regularly inspect tools especially benders for wear and damage that could lead to malfunction or create flying debris. - Provide training to all employees on safe operating procedures and emergency response actions pertaining to reinforcement bending operations. - Limit access to the operational area strictly to authorised personnel who have received adequate training and briefing. - Position safety screens or nets at strategic locations to capture or deflect any fragments produced during bending operations. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
