Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip hazards, Unsafe work area	2M	<ul style="list-style-type: none"> <li>- Conduct thorough site inspection and risk assessment prior to commencing any work to identify trip hazards, unsafe work areas or potential road blocks in the sewer relocation process.</li> <li>- Clearly mark all identified trip hazards or unsafe surfaces within the work area, ensuring that they are visible and easily recognizable by all on-site personnel.</li> <li>- Establish designated walkways throughout the work site to minimise the likelihood of tripping over obstacles while relocating the sewer.</li> <li>- Remove or address any unnecessary items or clutter in the work area that could potentially cause trip hazards, such as unused materials, tools, and equipment.</li> <li>- Provide appropriate personal protective equipment (PPE) - such as non-slip footwear, reflective vests, and hard hats - to all workers involved in the sewer relocation project to enhance safety awareness and reduce potential injuries.</li> <li>- Train workers to be vigilant and proactive when it comes to reporting and addressing potential hazards within the workplace. This will involve educating employees on the risks associated with trip hazards and the importance of maintaining a safe work environment.</li> <li>- Develop an effective communication process for alerting team members whenever a new hazard is identified on the work site. This can include a combination of verbal warnings, signage, or even mobile notifications.</li> <li>- Utilise proper materials-handling procedures when transporting construction debris, soil, or other heavy loads during the sewer relocation process. 			<ul style="list-style-type: none"> <li>- Ensure all workers are trained in safe manual handling techniques to avoid injury when relocating heavy materials, equipment, or sewer components.</li> <li>- Implement a system for regular monitoring and maintenance of the work area to ensure cleanliness, dryness, and hazard-free conditions throughout the project duration.</li> <li>- Identify the location of overhead power lines in the site assessment and establish a minimum safe working distance, in compliance with relevant Australian standards and guidelines.</li> <li>- Clearly mark out no-go zones around overhead power lines, using barriers and warning signs to prevent unauthorised access and remind workers to maintain safe distances.</li> <li>- Utilise non-conductive tools and equipment when working near overhead power lines to reduce the risk of electrocution if accidental contact occurs.</li> <li>- Equip machinery and vehicles with safety devices, such as proximity alarms or height limiting mechanisms, to help operators maintain safe working distances from overhead power lines.</li> <li>- Develop an emergency response plan for incidents involving overhead power lines, and ensure all workers are trained and competent in carrying out their roles within the plan.</li> <li>- Regularly review and update risk assessments and Safe Work Method Statements (SWMS) to account for changes in site conditions or newly identified hazards related to slips, falls, and overhead power lines.</li> <li>- Foster a strong safety culture on site by encouraging open communication and reporting of hazards, near misses, and incidents, empowering workers to actively participate in maintaining a safe work environment during the sewer relocation project.</li> </ul>

Excavation	Ground collapse, Contact with utilities	4A	<ul style="list-style-type: none"> <li>- Investigate and review site plans and utility locations in the area of excavation to avoid accidental contact with utilities.</li> <li>- Clearly mark out the excavation zone with barriers, warning signs or tapes to prevent unauthorised access to the site.</li> <li>- Implement a strict permit-to-work system, where only authorised personnel are allowed to operate within the excavation site.</li> <li>- Utilise up-to-date surveying and detection equipment for locating underground utilities and obstructions prior to excavation works.</li> <li>- Employ experienced operators who have received proper training in the safe practices associated with excavation work.</li> <li>- Ensure that regular inspections of the excavation site are conducted for signs of instability or other potential hazards, such as ground collapse or utility interference.</li> <li>- Use adequate shoring and support systems to stabilise the sides and walls of the excavation, preventing any possible ground collapse.</li> <li>- Schedule any necessary relocation of utilities before proceeding with excavation activities, particularly when their presence could pose a risk to workers' safety.</li> <li>- Insist on careful digging techniques, with an emphasis on minimising the risks of incidentally striking buried utilities.</li> </ul>	3H

- Have adequate emergency response plans in place for dealing with ground collapses or worker injuries, during the excavation process.

- Set up proper ventilation systems and air quality monitoring to detect the excavation area, especially if working near sewer lines or other

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
