Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Tool Inspection	Faulty tools, Exposure to sharp objects	3H	<ul style="list-style-type: none"> - Conduct a pre-use inspection of all tools to ensure they are in good working condition and free from damage. - Maintain an inventory of company-approved tools specifically designed for remote key programming to avoid using incorrect or incompatible equipment. - Implement a tool tagging system where tools that pass inspection are labeled with a "safe for use" tag, and faulty ones are marked clearly and removed from service. - Store all sharp objects, like knives or cutting implements, in protective sheaths when not in use to prevent accidental injury. - Employ engineering controls such as safety guards or covers on sharp tools wherever practicable to minimise exposure risks. - Require the use of personal protective equipment (PPE), including cut-resistant gloves, when handling sharp objects during tool inspections. 	2M

Site Set-Up	Slips, trips and falls, Electrical hazards	3H	<ul style="list-style-type: none"> - Conduct site inspection prior to set-up to identify any potential slip or trip hazards, such as loose wires or debris, and address them accordingly. - Use non-slip mats or surfaces if the ground is wet or uneven to prevent slips or trips during the work process. - Ensure that all electrical equipment used in remote key programming is tagged and tested for safety compliance under AS/NZS 3760 standards. - Utilize residual current devices (RCDs) on all electrical circuits to minimise the risk of electrical shock during operations. - Keep cables and cords organised using cable covers or ties to reduce the risk of tripping over electrical leads. - Erect clear signage around the work area indicating that remote key programming is in progress and to watch out for potential hazards. - Provide all workers with adequate personal protective equipment (PPE), including insulated gloves when handling electrical equipment. - Maintain good housekeeping practices by regularly removing waste materials and ensuring tools and equipment are safely stored when not in use. - Establish a designated safe area for personnel not directly involved in the programming process to prevent unnecessary movement in the work zone. - Regularly review and update risk assessments, incorporating feedback from employees to improve safety measures continually. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
