Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Incorrect manual handling, exposure to spores and allergens	3H	<ul style="list-style-type: none"> - Conduct a pre-work briefing to identify specific invasive plant types and associated risks. - Provide manual handling training emphasising safe lifting techniques and body posture. - Use personal protective equipment (PPE) such as gloves, masks, and long sleeves to minimise skin contact and inhalation of spores. - Implement a buddy system to ensure safe handling practices are followed and assistance is available if needed. - Use mechanical aids like dollies or wheelbarrows to transport large amounts of debris and reduce physical strain. - Schedule frequent breaks to minimise fatigue and ensure workers maintain correct handling techniques throughout the task. - Perform regular health monitoring for workers with a history of allergies or asthma to prevent adverse reactions. - Establish wash stations nearby for immediate decontamination in case of exposure to allergens or irritants. - Designate clearly marked disposal areas for plant material to avoid accumulation and cross-contamination of areas. - Ensure the work area is well-ventilated to disperse dust and spores effectively. - Educate workers on the identification and characteristics of target invasive species to enhance awareness and response readiness. - Regularly inspect tools and equipment to ensure they are well-maintained and suitable for the task. - Develop emergency procedures specifically addressing potential allergic reactions and involve all personnel in practice drills. 	2M

			<ul style="list-style-type: none"> - Ensure all workers carry a first aid kit, including items specific for insect bites such as antihistamines and epinephrine injectors, if prescribed. - Use insect nets or protective clothing when working in highly infested insect areas to minimize skin exposure. - Rotate job assignments to reduce time spent in high-risk areas, helping minimise exposure to falling branches and insect bites. - Conduct regular monitoring of weather conditions as wind and rain can increase the likelihood of branch fall and heightened insect activity. - Involve local biodiversity experts where necessary for insight into the behaviour and danger levels of indigenous species. - Clearly mark and document hazards (one area) within the site, including details on potentially hazardous trees and known insect nests. - Encourage workers to report any signs of branch instability or increased insect activity immediately to ensure prompt management. - Train employees in emergency response procedures related to injuries caused by falling branches and severe insect bites, including recognising symptoms and administering appropriate first aid until professional help arrives.

Tool Gathering	Incorrect use of tools, accidental injuries	3H	<ul style="list-style-type: none"> - Conduct pre-work safety briefing to ensure all team members are aware of proper tool handling and potential hazards. - Use appropriate personal protective equipment, including gloves, long sleeves, and eye protection, to minimise injury risks. - Ensure all tools are in good working order before use; conduct regular maintenance checks. - Clearly label and store tools properly when not in use to prevent trips and falls. - Provide training for all workers on the correct use of specific tools required for plant removal tasks. - Implement a buddy system so workers can assist each other with tool handling and immediate first aid if needed. - Clearly mark work areas with barriers or signs to prevent accidental entry by unauthorised personnel. - Use ergonomic lifting techniques to manage heavy or awkward tools safely. - Establish emergency procedures for injuries, ensuring all workers are aware of first aid locations and how to summon help quickly. - Designate a tool manager responsible for tracking tool usage and ensuring that tools are returned after use. - Utilise manual handling aids, such as trolleys or carts, to transport heavy tools to the work site. - Limit the number of non-essential personnel in the tool gathering area to reduce injury risks. - Schedule regular breaks during shifts to reduce exhaustion-related errors while using tools. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
