Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Excessive noise, Inhalation of gases and fumes	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify potential hazards and ensure appropriate control measures are in place. - Use hearing protection such as earmuffs or earplugs to mitigate the effects of excessive noise caused by the torch. - Perform work in a well-ventilated area, ideally outdoors or with mechanical ventilation systems, to disperse harmful gases and fumes. - Wear respiratory protection such as a suitable respirator or mask approved for filtering gases and fumes specific to oxyacetylene torches. - Ensure equipment is maintained regularly and checked for leaks to prevent inhalation hazards due to gas escape. - Isolate the work area to avoid exposure to colleagues or bystanders not involved in the repair task. - Implement administrative controls like scheduling noisy tasks during times when fewer workers are present to minimize overall exposure. - Provide training for operators on the correct use of the oxyacetylene torch and the associated risks to avoid accidents among those performing the task. - Clearly label all gas cylinders and maintain a safe distance between them and any sources of ignition or excessive heat. - Position gas cylinders upright and secure them properly to avoid tip-over incidents that could lead to gas release. - Use flashback arrestors on both torch and regulator ends to prevent flames from traveling back into cylinders. - Emphasize the use of flame-resistant PPE, including gloves and aprons, to provide an additional barrier against accidental exposure to sparks and hot surfaces. - Provide first aid facilities and ensure personnel are trained in responding to incidents related to fumes and inhalation. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
