Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Power Off Procedure	Electric shock, burns	2H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to commencing work to identify potential electrical hazards associated with the equipment. - Ensure all personnel are trained and competent in electrical safety and lockout/tag-out (LOTO) procedures. - Disconnect power at the main switch board ensuring that it is clearly labelled and isolated from the work area. - Use lockout/tag-out devices on switches and controls to prevent accidental re-energising of equipment during maintenance. - Verify the absence of voltage using appropriate test instruments before beginning any work on the equipment. - Wear appropriate personal protective equipment (PPE) such as insulated gloves and protective eyewear to guard against electric shock and burns. - Implement a buddy system where another qualified person confirms the isolation process to increase safety. - Display visible warning signs and barriers around the work area to alert others of ongoing maintenance activities. - Prohibit the use of conductive tools and materials near live parts to reduce the risk of accidental contact. - Maintain strict access control to the area, allowing only authorised personnel who are fully briefed on safety procedures. - Test nearby circuits and equipment for their de-energised state to ensure no accidental power source is available. - Maintain clear communication amongst team members throughout the procedure to coordinate actions and respond to emergencies promptly. - Conduct regular audits and reviews of the lockout/tag-out process to ensure compliance and effectiveness. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
