Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Vehicle collision, Inadequate training	3H	<ul style="list-style-type: none"> - Ensure all personnel involved in the operation are trained and qualified in both driving safely and wildlife rescue procedures. - Conduct a comprehensive risk assessment before commencing any wildlife rescue to identify potential hazards including terrain and weather conditions. - Establish clear communication protocols among team members using radios or mobile phones to coordinate efforts effectively and safely. - Implement strict vehicle speed limits in areas where wildlife is likely to be present to minimise the risk of collisions. - Use signage and barriers to alert other vehicles of the presence of a rescue operation underway, thereby reducing the chance of collision. - Schedule regular refresher training sessions for all staff involved in wildlife rescue to update them on best practices and new techniques. - Equip rescue vehicles with high-visibility markings and emergency lights to increase visibility to other road users. - Ensure all equipment used for wildlife rescue is checked and maintained regularly to avoid malfunctions that could endanger either the crew or the animals. - Develop an emergency response plan specific to vehicle collisions or other accidents that may occur during the operation. - Allocate a safety officer responsible for overseeing that all safety protocols are followed throughout the operation, including the proper loading and transportation of rescued wildlife. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
