Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Mixing Resin Components	Chemical reaction hazards, Fire hazards	4A, 3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment and have it reviewed by qualified personnel before commencing the task. - Ensure all personnel involved are trained in the safe handling and mixing of resin components. - Use appropriate personal protective equipment (PPE), including gloves, goggles, and respiratory protection, to guard against exposure to harmful chemicals. - Maintain good ventilation in the work area to minimise inhalation of vapours and fumes; use mechanical ventilation if necessary. - Establish a well-defined mixing procedure to prevent accidental misuse or incorrect mixing ratios that could lead to dangerous chemical reactions. - Store reactive components separately until just prior to mixing to limit the risk of unintentional contact and reaction. - Use intrinsically safe equipment and tools made of non-sparking materials to mitigate fire risks when working around flammable substances. - Clean labels and store all chemicals safely, following safety data sheets (SDS) guidelines, away from ignition sources. - Keep fire extinguishing equipment readily accessible at the mixing site and ensure staff are trained in its use. - Implement spill containment measures, such as absorbent mats and trays, to swiftly manage spills and leaks during mixing. - Monitor the mixing process for signs of an uncontrolled reaction, such as excessive heat generation or unusual fumes, and have procedures in place for immediate cessation of activity. - Prohibit smoking, open flames, and other ignition sources in the vicinity of the mixing area. - Install clear signage indicating hazard zones and required safety practices within the mixing area. - Conduct regular inspections and maintenance of equipment used in mixing activities to ensure all tools and containers remain in safe operating condition. 	2M, 2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
