Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Setting Out	Miscommunication, wrong measurements	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to clearly outline roles and responsibilities, ensuring all team members understand the project requirements. - Use detailed site plans and drawings to confirm accurate layout and measurements before starting work. - Implement a double-check system where critical measurements are verified by a second qualified person. - Clearly mark out key points using high visibility stakes or markers to avoid miscommunication on site. - Ensure constant communication through tools like two-way radios or mobile phones, especially in large or noisy work areas. - Set up a clear chain of command so everyone knows who to refer questions or issues to during the setting out phase. - Provide training for all workers involved in the setting out process to ensure they understand how to accurately interpret plans and drawings. - Regularly review the project plan and progress with the team to identify any discrepancies or changes needed as early as possible. - Use laser levels or other similar technology to increase the accuracy of measurements over traditional methods. - Have a documented procedure for addressing and correcting wrong measurements immediately to minimise impact on the overall project timeline. - Limit access to the setting-out area to only those personnel directly involved in this stage of work to reduce the risk of accidental alterations to markers or measurements. - Document all measurements and settings systematically, maintaining records for accountability and future reference. - Ensure adequate lighting in the area where setting out is taking place to prevent errors due to inadequate visibility. - Utilise signage and barriers to highlight existing utilities or obstacles that could affect the setting out process or lead to wrong measurements. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
