Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

3. Cleaning Process	Dust inhalation, Slips owing to wet surfaces	3H	<ul style="list-style-type: none"> <li>- Ensuring all workers are provided with Personal Protective Equipment (PPE), such as dust masks and respirators, to prevent dust inhalation.</li> <li>- Implement regular wetting down of road surfaces, especially in dry conditions, to help reduce the amount of airborne dust.</li> <li>- Training of workforce on proper handling of machinery, ways to minimise dust creation, and safe processes to follow if encountering slip, trip or fall risks.</li> <li>- Periodic maintenance and service checks of the road sweeper. Making sure that all components are functioning properly can help keep a lid on dust emissions.</li> <li>- Provision of non-slip footwear for workers as part of their PPE to offer better safety on wet surfaces.</li> <li>- Ensuring the cleaning is done in sections and areas cordoned off, which can help manage wet surface areas and prevent accidental slips.</li> <li>- Regular resting periods for workers who are working in dust-prone areas as continuous exposure can be harmful even when using PPE.</li> <li>- Following the procedure of gradual and systematic cleaning rather than rushing it can also mitigate slip hazards from sudden wet patches.</li> </ul>	2M

Dealing with Heavy Traffic	Accidents, Noise pollution	4A	<ul style="list-style-type: none"> <li>- Develop and follow a defined Traffic Management Plan, where required to effectively minimise congestion and avoid accidents.</li> <li>- All operators should be provided with thorough training on how to safely manoeuvre the sweeper in heavy traffic conditions, including sudden stops and high lane changes.</li> <li>- Road sweepers should have all necessary lights, signals, and reflective material for high visibility. Operators should always ensure that these features are functioning correctly before commencing work.</li> <li>- Regular breaks must be planned, especially for tasks involving longer durations, to mitigate the risks associated with fatigue.</li> <li>- The use of high-quality noise-cancelling headphones should be promoted among workers to protect against long-term hearing damage from excessive noise levels.</li> <li>- Maintenance of vehicles should be done regularly to keep them in optimum condition, reducing the chances of unexpected breakdowns amidst traffic.</li> <li>- An Emergency Response Plan (ERP) should be formed and rehearsed by all staff members to ensure immediate action during any unforeseen incidents.</li> <li>- Staff should be properly trained to communicate effectively with other road users via signals to prevent misunderstanding leading to an accident.</li> <li>- Use appropriate personal protective equipment (PPE), including vests with high-visibility markings to make workers easily noticeable within the traffic.</li> <li>- Avoid working during peak traffic hours or seek for local authority support to manage/control traffic when necessary.</li> <li>- Ensure communication devices are available and properly functioning for seamless communication amongst team members during operations.</li> </ul>	2M

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
