Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> <li>- Establish a clear boundary around the working area to keep unauthorised personnel from entering the space while the Robot Welder is being programmed, reducing the chance of incidents occurring due to human error or curiosity.</li> <li>- Maintain ongoing communication among team members responsible for programming and operating the Robot Welder, ensuring everyone is aware of potential hazards and follows defined safety procedures.</li> <li>- Keep all guards and safety devices in proper working condition and check these components regularly, repairing or replacing any malfunctioning parts immediately.</li> <li>- Regularly inspect cables and connections used during the programming process, ensuring they are free from wear or damage that could lead to accidents or injury, resulting in crush injuries or pinch points.</li> <li>- Avoid material buildup or clutter within the workspace to reduce the chance of slips, trips, and falls that could result in injury within the vicinity of the Robot Welder.</li> <li>- Continuously monitor the Robot Welder's movements and operations during the programming phase to identify any unexpected behaviours or changes that could potentially cause harm to operators or other individuals in the area.</li> <li>- Foster a strong safety culture within the workplace by holding regular meetings, providing up-to-date training, and encouraging open feedback about potential hazards, near-misses, and improvements to health and safety practices related to the Robot Welder's operation.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
