ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Schedule routine maintenance checks for all moulds and equipment to identify defects early and rectify them promptly. - Clearly mark defective moulds with "do not use" signs until they have been repaired or replaced to avoid accidental usage. - Develop a protocol for reporting and addressing defective equipment immediately, ensuring timely repairs or replacements are made. - Use adequate lighting in all areas where mould inspection takes place to ensure hazards like sharp edges can be easily seen and addressed. - Establish a dedicated area for mould inspection that is free from clutter to reduce the risk of workers coming into contact with sharp edges unexpectedly. - Introduce a lockout/tagout procedure for equipment being inspected or under repair to prevent accidental operation during maintenance. - Regularly update inspection procedures to incorporate new safety standards or technology advancements in the industry. - Encourage a culture of safety where employees feel comfortable raising concerns about potential hazards and suggesting improvements.

Material Loading	Dust inhalation, Chemical spills	3H, 4A	<ul style="list-style-type: none"> - Provide appropriate personal protective equipment (PPE) such as respirators with dust filters and gloves for handling chemicals. - Install local exhaust ventilation systems to capture dust at the source and reduce airborne particulates. - Ensure all workers receive training on proper material handling techniques and the potential hazards of materials used. - Implement procedures for safe loading methods to minimise the disturbance of dust during the transfer of materials. - Use enclosed conveyors or vacuum systems where possible to reduce the generation of dust during material transfer. - Regularly maintain and inspect equipment to ensure there are no leaks or failures that could lead to spills or excess dust. - Clearly label all chemical containers with hazard information and ensure safety data sheets are accessible to workers. - Establish spill response procedures and provide readily available spill kits in case of accidental releases. - Limit the number of personnel in the area during material loading to those absolutely necessary for the operation. - Monitor air quality regularly to ensure dust levels remain within acceptable occupational exposure limits. - Implement housekeeping practices to promptly clean up any spills or dust accumulations using approved methods. - Ensure good workplace ventilation in addition to local exhaust systems to maintain air quality. 	2M, 2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
