Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ensure all workers involved in material delivery are trained in proper manual handling techniques. Use mechanical aids such as forklifts or pallet jacks to move heavy materials whenever possible. Establish clear communication and hand signals among team members during lifting and moving of materials. Ensure the delivery area is clear of obstacles and hazards before unloading materials. Assign a spotter to guide the delivery vehicle and assist with unloading operations to avoid collisions and mishaps. Ensure all personal protective equipment (PPE) such as gloves, steel-toed boots, and high-visibility clothing is worn by all personnel handling materials. Limit the weight of manually lifted loads to within safe lifting guidelines for individual workers. Rotate workers frequently to prevent fatigue and reduce the risk of injury from repetitive movements. Implement the buddy system for lifting tasks, ensuring that no worker lifts a heavy load alone. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- Spot Checks.
- 2. Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
