If an incident or a near miss occurs, all work must sto, an alately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.			
Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Inspect Equipment	Possible malfunction, Electrical shock	ЗН	 Ensure all maintenance personnel are trained and competent in handling sawdust extraction systems. De-energise and lock out the electrical supply to the equipment before starting inspection. Use insulated tools and wear rubber-soled shoes to minimise risk of electrical shock. Conduct a visual inspection of cables, plugs, and connections for any signs of wear or damage. Confirm that emergency stop mechanisms are functioning properly prior to commencing work. Verify that Personal Protective Equipment (PPE) such as safety goggles and gloves is available and worn by workers. Implement a regular inspection schedule to identify and rectify potential malfunctions early. Clearly label and isolate defective equipment to prevent unintentional use until repairs are completed. Use a certified electrician for any necessary electrical repairs or adjustments. Keep a detailed log of inspections and maintenance activities to track system performance and issues. Maintain clear access around the equipment to facilitate safe inspection and repair operations. Ensure proper illumination around the equipment to effectively identify possible malfunctions. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:
