ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slip, trip and fall hazards, Chemical exposure to cleaning agents	2M	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify and remove or highlight any obstacles or debris that could cause slips, trips, or falls. - Post clear signage and barriers to alert staff and visitors of wet floors and the cleaning process in progress. - Ensure all workers are wearing appropriate personal protective equipment including non-slip shoes and gloves. - Select cleaning agents that are less hazardous and ensure proper dilution according to manufacturer's instructions. - Provide adequate ventilation to disperse chemical fumes when using cleaning agents. - Train workers on the safe handling, usage, and storage of cleaning chemicals, emphasizing the importance of reading safety data sheets (SDS). - Implement a buddy system where team members can watch out for each other and offer assistance if needed. - Before starting, verify that tools and equipment are in good condition and that industrial brushes are securely attached. - Designate specific pathways for workers to prevent accidental contact with wet surfaces and work areas. - Schedule floor scrubbing during times when foot traffic is minimal to reduce the risk of accidents. - Ensure there is easy access to material safety data sheets and first aid supplies in case of exposure to cleaning agents. - Have emergency contact numbers and procedures clearly displayed in work areas in case of an incident. 	1L

Inspection of Cleaning Equipment	Contact with faulty equipment, Electrical hazards	3H	<ul style="list-style-type: none"> - Ensure all equipment is tagged and tested in accordance with Australian safety standards. - Conduct a visual inspection of equipment before each use to identify any visible damage or wear and tear. - Implement a regular maintenance schedule for all cleaning equipment to prevent malfunctions. - Use only equipment that has been verified as safe by completing a pre-use checklist. - Ensure all electrical cords are intact, free from cuts or frays, and have earth pins intact. - Keep all cables and cords away from water and wet areas to prevent electrical hazards. - Provide training to workers on how to properly inspect equipment for potential faults. - Make sure all power outlets used are RCD (Residual Current Device) protected. - Report any damaged or faulty equipment immediately and remove it from service until repaired. - Store all cleaning equipment in a designated dry area when not in use to avoid moisture exposure. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
