Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Ladder set-up	Falling from heights, Incorrect use	3H	<ul style="list-style-type: none"> - Select the appropriate ladder size and type for the task, ensuring it is designed for work at heights. - Inspect the ladder for any damage or defects before use, including checking the rungs, side rails, and feet. - Place the ladder on a stable, level surface to prevent it from slipping or toppling over. - Secure the ladder at the top or have a co-worker hold it steady while in use to provide additional stability. - Ensure the base of the ladder is one metre away from the structure for every four metres of height (4:1 ratio). - Use a non-slip safety mat or anti-slip devices under the ladder feet if set up on a smooth or slippery surface. - Keep three points of contact with the ladder at all times while climbing and working (two hands and one foot, or two feet and one hand). - Wear appropriate non-slip footwear to improve grip and reduce the risk of slipping when using the ladder. - Set up barriers or signage around the work area to prevent accidental bumping into or destabilising the ladder by unauthorised personnel. 	1L

Gutter inspection	Slips, trips and falls, Falls from height	3H	<ul style="list-style-type: none"> - Conduct a pre-work safety briefing to ensure all workers understand the potential hazards and control measures. - Use appropriate personal protective equipment including non-slip footwear, gloves, and hard hats. - Ensure secure ladder placement on stable ground, angling it correctly and extending at least one metre above the working surface. - Implement fall arrest systems such as harnesses and lanyards for work over two metres. - Assign a spotter to hold the ladder or assist with securing access points. - Inspect ladders and any elevation equipment for defects prior to use, ensuring they are in good working condition. - Use scaffolding where possible instead of ladders, ensuring it is erected and inspected by competent personnel. - Remove any debris and obstacles around work areas to prevent trips and slips. - Ensure gutters are dry before inspection if possible, to minimise slip risks. - Work in pairs or teams where feasible to ensure assistance in case of emergency. - Secure tools and materials to prevent them from falling and posing additional hazards to workers below. - Schedule inspections during daylight hours and avoid work in adverse weather conditions such as rain or strong winds. - Maintain clear communication among team members using hand signals or radios when visibility is restricted. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
