Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Ladder Placement	Misplaced ladder, Unstable ladder	3H	<ul style="list-style-type: none"> - Select the correct ladder type and height for the task to maintain stability and reach. - Inspect the ladder for any damage or defects before use, including rungs, side rails, and locking mechanisms. - Ensure the ladder is placed on a stable, flat surface to prevent slipping or tipping. - Position the ladder at the correct angle, ideally with a 4:1 ratio (one metre out for every four metres up). - Avoid placing ladders on slippery surfaces, such as wet, oily, or icy areas. - Secure the base of the ladder by using non-slip devices or securing it to prevent movement. - Maintain three points of contact (two hands and one foot or two feet and one hand) while ascending or descending the ladder. - Do not overreach while on the ladder; keep your body centred between the side rails. - Ensure that only one person is on the ladder at any time unless specifically designed for more. - Wear non-slip, sturdy footwear to reduce the chance of slipping off the rungs. - Use a tool belt or hoist line to transport tools or materials, keeping hands free for climbing. - Clearly mark the area surrounding the ladder to prevent accidental displacement by other workers. - Erect barriers or warning signs around the ladder's location to alert others to its presence. - Regularly train employees on proper ladder safety procedures and ensure compliance through supervision and reinforcement. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
