Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Incorrect Manual Handling, Slips, Trips and Falls	2M	<ul style="list-style-type: none"> - Conduct a pre-start briefing to ensure all workers understand the task requirements and associated risks. - Use mechanical aids such as trolleys or hoists to transport shingles and other materials to reduce manual handling. - Assess the work area for slip, trip, and fall hazards before starting, and remove any obstructions or debris. - Ensure proper personal protective equipment (PPE) is worn, including sturdy non-slip footwear and gloves. - Implement a traffic management plan to keep the work area clear of vehicles and pedestrian access when working manually. - Provide adequate lighting in the work area to enhance visibility and reduce the risk of trips and falls. - Train workers in correct manual handling techniques to minimise strain and prevent musculoskeletal injuries. - Set up temporary barriers or warning signs around the work zone to alert others to the hazard. - Ensure all tools and equipment are in good working order and fit for purpose, conducting regular inspections and maintenance. - Designate safe walkways or pathways within the work area and ensure these remain free from clutter at all times. - Store materials neatly and securely to prevent them from becoming trip hazards or falling unexpectedly. - Utilise safety harnesses or fall arrest systems when working at heights if required by site conditions. - Monitor weather conditions and cease work in adverse conditions, such as rain or high winds, that increase the risk of slips and falls. - Engage spotters to guide and assist workers during the transport of heavy or awkward loads. 	1L

Replace any damaged items immediately. - Use Residual Current Devices (RCDs) at all times when using electrical equipment to prevent electric shock. - Maintain a clear workspace, ensuring any flammable materials are kept well away from heat sources and electrical equipment. - Store all combustible materials in appropriate containers, following guidelines for flammable storage, and keep away from work area. - Ensure staff are trained in identifying and managing potential fire hazards, and know the proper use of fire extinguishers. - Designate and maintain access to emergency exits and ensure they are clearly marked and unobstructed at all times. - Establish and communicate emergency procedures, ensuring workers are familiar with evacuation routes and muster points. - Place portable fire extinguishers nearby and ensure they are regularly serviced and inspected according to regulations. - Prohibit smoking and open flames within the vicinity of the work area to reduce fire risks. - Conduct a pre-work safety briefing focusing on specific tasks, highlighting potential hazards and reminding workers of control measures. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
