Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper training, Weather conditions	3H	<ul style="list-style-type: none"> - Ensure all workers involved in the task have completed appropriate training and have been briefed on the specific risks associated with securing panels on windy days. - Conduct a pre-start meeting to discuss the weather conditions and adjust work plans as necessary based on the current and forecasted wind speeds. - Use a reliable weather forecasting service and monitor updates throughout the day to stay informed about changing conditions. - Establish a clear communication plan for all team members, including how to alert others if conditions deteriorate rapidly. - Set up barriers and signage around the work area to prevent unauthorised access, especially if winds are high and could pose a risk of flying debris. - Opt for personal protective equipment (PPE) suited for high-wind scenarios, such as safety goggles, harnesses, and gloves with good grip. - Ensure that all tools and equipment used in securing panels are in excellent condition and regularly inspected to avoid malfunctions during windy conditions. - Use mechanical aids, such as clamps or temporary braces, to provide additional stability to panels before they are permanently secured. - Schedule securing panel tasks during the calmest parts of the day whenever possible, usually early morning or late afternoon. - Develop an emergency response plan tailored for windy conditions, ensuring all workers are aware of their roles and responsibilities if an evacuation is required. - Limit the workforce to essential personnel only when high winds are present to reduce exposure and enhance control measures. - Regularly review and update safety protocols and procedures in line with previous incidents, lessons learned, and improvements in technology or regulations. - Position windbreaks strategically around the site to mitigate the impact of wind gusts on unsecured panels and reduce overall hazard potential. - Conduct regular drills simulating high-wind emergencies so that all personnel remain familiar with safety procedures and are able to react swiftly and efficiently in real situations. 	2M

			<ul style="list-style-type: none"> - Use only certified and approved lifting equipment that is suitable for the weight and dimensions of the panels being selected, ensuring regular maintenance checks are completed. - Implement a strict worksite protocol that mandates all non-essential personnel maintain a safe distance from the panel selection area to minimise the risk of injury from falling objects. - Designate a competent supervisor to oversee the selection process, ensuring adherence to safety procedures and immediate correction of any unsafe practices. - Utilise wind speed indicators on site to monitor conditions, and cease panel handling during high winds or if gusts exceed safe operational limits as specified in the project safety plan. - Pre-inspect all panels for damage or defects before selection, rejecting any that may compromise structural integrity and increase the risk of dropping during installation. - Arrange for clear communication protocols, such as radios or hand signals, among team members involved in panel selection to ensure coordination and immediate response capabilities in case of an incident. - Secure the down panels not currently being installed to prevent accidental movement due to wind, using ropes or straps that are designed to withstand environmental pressures. - Establish exclusion zones around areas where panels might be dropped or mishandled, clearly marking these zones with barriers or signs to alert workers to stay clear of potential danger areas.

Transport of Panels	Trip fall hazards, Manual handling injuries	3H	<ul style="list-style-type: none"> - Ensure workers are trained in manual handling techniques to reduce the risk of injury during transport. - Use appropriate lifting equipment such as trolleys or forklifts where possible to minimise manual handling. - Conduct a site inspection before panel transport to identify and remove potential trip hazards like debris or uneven surfaces. - Clearly delineate transport paths and keep them clear of obstacles to prevent trips and falls. - Use personal protective equipment such as gloves and sturdy footwear to enhance grip and safety during manual handling. - Implement a two-person lift policy for larger panels to ensure balanced load distribution and reduce strain. - Secure panels on trolleys or other transport devices with straps or restraints to prevent unexpected movement. - Schedule transports during periods of lower site activity to minimise crowding and decrease the likelihood of trips and falls. - Provide onsite supervision to ensure that all safety protocols are followed during panel transport. - Use wind barriers or wait for calmer conditions if high winds pose a risk during panel transport. - Mark all potential hazard areas clearly with signs or cones to alert staff and encourage caution. - Allow regular breaks for workers involved in manual handling to reduce fatigue and potential for injuries. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
