Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Rack instability, Falling objects from rack, Pinch points	3H	<ul style="list-style-type: none"> - Conduct a pre-inspection of the area to identify any potential hazards associated with unstable racks. - Ensure all workers involved are trained in manual handling and aware of the risks linked to rack instability. - Use appropriate personal protective equipment (PPE), such as hard hats, gloves, and steel-toed boots, to protect against falling objects and pinch points. - Limit access to the work area to authorised personnel only to prevent unauthorised movement that could destabilise the racks further. - Confirm that the base of each rack is stable and secured to prevent tipping or shifting during operations. - Mark and clearly communicate the boundaries of the working area to all personnel on-site to maintain awareness and safety. - Use caution signs and visual warnings around the site to notify workers and bystanders of the potential risks present. - Secure and strap down any loose items on the racks to prevent them from falling while adjustments are being made. - Use mechanical aids such as forklifts or cranes for heavy lifting to avoid physical strain and related injuries. - Establish a communication protocol among team members to ensure clear and efficient coordination throughout the task. - Avoid overloading any section of the racks by adhering to the manufacturer's load capacity specifications. - Implement a spotter system, where one person monitors stability while another performs adjustments or relocations. - Develop an emergency response plan specific to the activity, ensuring all workers are familiar with evacuation routes and procedures in case of an incident. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
