Implement a buddy system or spotter for tasks requiring extra vigilance, ensuring that colleagues are looking out for one another. Encourage open communication between workers and supervisors, making it easy to report new hazards or changing conditions in the workspace. When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
