Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.			
The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

2. Inspection of vehicle suspension system			 Wear appropriate personal protective equipment, such as gloves and safety glasses, to prevent exposure to harmful substances. Utilise ventilation systems or masks if working in an area with insufficient airflow to mitigate inhalation of fumes or dust. Ensure the vehicle is parked on a stable, even surface and engage handbrakes to prevent any unexpected movement. Place wheel chocks or blocks under the vehicle's wheels to secure it from rolling unexpectedly. Use vehicle hoists or jack stands as specified by the manufacturer for additional support; ensure they are correctly positioned and securely locked in place. Isolate the vehicle's energy sources by disconnecting the battery to prevent unintentional activation of moving parts. Develop and follow strict lockout/tagout procedures while inspecting or servicing the suspension components. Maintain clear communication with all team members involved to ensure everyone is aware of ongoing tasks and potential hazards. 








When the SWMS has been revised the PCBU must ensure that persons involved with the work are advised that a revision has been made and how they can acces he revised SWMS, including all persons who will need to change a work procedure or system as a region of the review are advised of the changes in a way that will enable them to implement their duties antly with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- 1. Spot Checks.
- 2. Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies. followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
