### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips, and falls, Manual handling injuries	2M	<ul style="list-style-type: none"> <li>- Implement housekeeping practices: Ensure that the work area is clean, well-organised and free from clutter, debris or any obstacles which may lead to slips, trips, and falls.</li> <li>- Use appropriate footwear: Workers should wear slip-resistant shoes or boots with good treads and proper ankle support to minimise the risk of slipping, tripping or falling.</li> <li>- Inspect flooring surfaces: Regularly check for any wet, slippery or uneven surface areas and address any hazards immediately (e.g., drying the floor or using temporary matting).</li> <li>- Mark/identify potential hazards: Clearly mark any potential slip, trip, and fall hazards with signs or barrier tapes to alert workers and help prevent accidents.</li> <li>- Provide training on manual handling techniques: Educate workers on proper lifting techniques and how to carry objects safely so as not to strain their backs or other body parts.</li> <li>- Utilise mechanical aids: Encourage the use of equipment such as hand trucks, dollies, or mobile carts to move heavy or bulky items instead of manually lifting them.</li> <li>- Store tools and equipment properly: Keep all tools, materials, and equipment stored in designated locations when not in use, maintaining clear pathways and reducing the risk of injuries related to manual handling.</li> <li>- Plan ahead for heavy lifting: Identify tasks involving heavy lifting in advance and break down these tasks into smaller, manageable loads, or arrange for additional help from coworkers.</li> <li>- Design ergonomic workspaces: Arrange often-used items within easy reach (between knee and shoulder height) to minimise bending, stretching, or twisting motions while working on taps and water bubblers.</li> <li>- Rotate job tasks: If possible, rotate employees between different tasks to reduce repetitive motion and decrease the risk of manual handling injuries over time.</li> <li>- Take regular breaks: Encourage workers to take short, frequent breaks to stretch or rest, especially if they are engaged in physically demanding tasks.</li> <li>- Communicate openly about hazards: Encourage an open dialogue between employees and supervisors regarding concerns or issues related to workplace safety, so that any risks can be addressed promptly.</li> <li>- Maintain equipment in good condition: Regularly inspect and maintain tools, equipment, and personal protective gear to ensure they are functioning properly and can be safely used during servicing taps and water bubblers.</li> </ul>	1L

			<ul style="list-style-type: none"> <li>- Keep the work area dry and free from any water sources that could cause an electrical hazard.</li> <li>- Provide temporary barriers or warning signs around the work area to alert other workers of the ongoing servicing activities and potential hazards.</li> <li>- Verify the proper isolation of valves and power supply by testing them before starting any work on taps and water bubblers.</li> <li>- Schedule regular maintenance and inspection of electrical equipment to ensure its safety and functionality, lowering the chances of an unexpected electric shock.</li> <li>- Train workers on best practices for servicing taps and water bubblers, including how to safely isolate and handle electrical equipment.</li> <li>- Employ a permit-to-work system to ensure only competent and authorised personnel are allowed to carry out specific tasks related to isolation and servicing.</li> <li>- Implement emergency response procedures in case of accidental valve operation, including immediate stop-work protocols and timely incident reporting.</li> <li>- Regularly communicate safety reminders and toolbox talks to staff reinforcing the importance of following isolation procedures and proactive reporting of potential hazards.</li> <li>- Maintain up-to-date records of training, equipment inspections, and maintenance activities as evidence of a robust safety management system.</li> <li>- Continuously review and update the SWMS based on lessons learned, changes in work processes, or regulatory requirements to ensure its effectiveness in managing risks associated with isolation and valve operation while servicing taps and water bubblers.</li> </ul>

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
