Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Material handling injuries, Trip/Fall Hazards	2M	<ul style="list-style-type: none"> - Ensure all workers involved have received training on proper manual handling techniques to reduce the risk of material handling injuries. - Use mechanical aids such as trolleys or lift-aids devices when transporting heavy materials to minimize physical strain on workers. - Arrange materials at the installation site in an organised manner to prevent clutter and reduce trip hazards. - Conduct a pre-work site inspection to identify potential trip hazards, such as uneven surfaces, and implement corrective actions prior to commencing work. - Provide appropriate personal protective equipment (PPE) such as gloves and safety footwear to protect against handling and injuries and slips. - Mark pathways and work zones with high-visibility tape to clearly define safe walking and working areas. - Ensure adequate lighting is available throughout the working area to enhance visibility and help workers identify potential tripping hazards. - Regularly communicate with the team about the importance of housekeeping to maintain a tidy workspace and avoid accumulation of debris. - Position tools and materials within easy reach to minimize unnecessary movement and twisting that can lead to injury. - Establish a clear protocol for safely storing tools and materials when not in use to prevent obstruction of walkways. - Supervise manual handling tasks to ensure adherence to safe practices and make necessary adjustments based on observed risks. 	1L
2. Ladder Set-up	Fall from height, Incorrect equipment use	3H	<ul style="list-style-type: none"> - Conduct a pre-use inspection of the ladder to ensure it is in good condition, checking for any damage, rungs, or feet that may compromise stability. - Ensure ladders are of an appropriate height so employees do not stand on the top two rungs, maintaining three points of contact to prevent falls. - Position the ladder on a stable and level surface; use a footing device or secure the base to prevent slipping or movement. - Utilise only industrial-grade ladders that comply with Australian Standards, ensuring they are suited for the load and height requirements of the task. - Set up the ladder at a 4:1 angle (one metre out for every four metres up) to optimise balance and minimise the risk of tipping over. - Ensure all workers have received adequate training on correct ladder usage, including setup, stability, and load-bearing limitations. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
