Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Engine cool down	Burn injuries, Slips and trips	3H	<ul style="list-style-type: none"> - Allow sufficient time for the engine to cool down before commencing work, ideally at least 30 minutes after turning off. - Wear heat-resistant gloves to protect hands from residual heat on engine components. - Use a thermometer or infrared thermometer to check the engine temperature before starting the task. - Clearly mark and designate a specific work area around the vehicle to prevent unnecessary access during cool down. - Ensure adequate lighting around the work site to minimise risk of missteps or tripping. - Keep the work area clear of any oil spills or debris that could cause slips or trips. - Place non-slip mats around the work area to improve footing stability. - Display warning signs indicating 'Hot Engine' to inform other workers or bystanders of potential hazards. - Maintain an organised workspace with tools and equipment placed in designated areas to reduce clutter. 	2M

Removal of old spark plugs	Electrical shock, cuts or abrasions	1H	<ul style="list-style-type: none"> - Ensure the engine is turned off and has had sufficient time to cool down before starting any work to prevent burns and electrical shock. - Remove the key from the ignition and disconnect the battery to eliminate the risk of electrical shock. - Use insulated tools specifically designed for automotive repairs to reduce the chance of electric shocks. - Wear appropriate personal protective equipment such as gloves with cut resistance and safety goggles to minimise risks of cuts, abrasions, and eye injuries. - Confirm proper lighting in the workspace to ensure visibility and reduce the likelihood of accidental injury or tool slippage. - Keep hands clear of sharp edges and surrounding components when accessing spark plugs to avoid cuts and abrasions. - Implement a clean workspace policy to prevent tripping hazards and unintended contact with sharp objects. - Use a torque wrench to safely loosen and remove spark plugs, ensuring that no excessive force causes tool slippage which could lead to injury. - Bench test each spark plug socket fit prior to use on live components to confirm adequate grip and prevent accidents. - Dispose of old spark plugs responsibly and ensure they do not pose additional hazards in the workspace. - Train workers on handling techniques for spark plugs and related tools, focusing on safe practices to mitigate risks at all stages. - Report and address any issues in existing personal protective equipment, including wear and tear, before beginning this task. - Conduct a risk assessment by identifying potential hazards specific to the work environment and take steps to control those risks effectively before any hands-on activity. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
