Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Component Handling	Sharp edges causing injuries, heavy loads leading to musculoskeletal injuries	3H	<ul style="list-style-type: none"> - Conduct a risk assessment prior to handling components to identify specific sharp edges and weight distribution of heavy loads. - Provide appropriate personal protective equipment (PPE) such as cut-resistant gloves, steel-toed boots, and long-sleeve clothing to protect against sharp edges and potential injuries. - Utilise mechanical aids like forklifts, hoists, or trolleys to move heavy loads and minimise manual lifting whenever possible. - Train all personnel in correct manual handling techniques, emphasising safe lifting practices to prevent musculoskeletal injuries. - Implement a buddy system for moving particularly heavy or awkwardly shaped items to ensure balanced lifting and additional support. - Clearly mark and communicate any sharp edges on components using high-visibility labels or tape. - Regularly inspect and maintain mechanical aids to ensure they are in good working condition and safe to use. 	2M

Assembly Process	Finger entrapment, electrical hazards	3H	<ul style="list-style-type: none"> - Provide training to all workers on the specific risks associated with finger entrapment and electrical hazards in spire assembly. - Enforce the use of personal protective equipment, such as insulated gloves and protective clothing, to minimise risk of injury from electrical hazards. - Implement a lockout/tagout procedure to ensure equipment is de-energised before performing maintenance or repair. - Use non-conductive tools and insulated mats when working near electrical components to reduce the risk of electrocution. - Maintain a clean and organised work environment to prevent accidental contact with electrical components and reduce tripping hazards. - Regularly inspect all electrical systems and connections to identify and rectify any faults or wear that could pose a danger. - Install guards or barriers around moving parts of the machinery to prevent finger entrapment. - Schedule regular safety drills and emergency response simulations to prepare workers for potential incidents involving electrical shocks or entrapment. - Position warning signs and labels near hazardous areas and equipment to alert workers to potential dangers. - Limit access to high-risk areas to trained personnel only, reducing the number of individuals exposed to potential hazards. - Incorporate automatic shut-off mechanisms on machinery to immediately stop operation if a fault is detected. - Ensure all electrical equipment used is compliant with Australian safety standards and regularly tested for safety and functionality. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
