Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip and fall hazards, dropped objects	3H	<ul style="list-style-type: none"> - Conduct a site inspection to identify potential trip hazards and clear the area of obstructions prior to commencing work. - Ensure all workers are trained in proper manual handling techniques and are aware of potential hazards associated with stacking and unstacking loads. - Use appropriate signage to warn of work in progress and highlight specific areas where tripping or falling hazards may exist. - Provide adequate lighting of the work area to ensure visibility of any potential hazards and the tasks being performed. - Utilise safety barriers, cones to cord off areas where stacks are being assembled or dismantled to prevent unauthorized access. - Inspect all equipment and lifting gear for damage or wear before use, and ensure items are fit for purpose and within weight limits. - Allocate enough space around the work area to perform stacking and unstacking safely without having to manoeuvre in cramped conditions. - Store materials at an appropriate height to minimise the need for excessive reaching or bending that could result in loss of balance or dropped objects. - Encourage the use of team lifting for heavy or awkwardly shaped loads to distribute weight and reduce strain on individual workers. - Implement a communication system, such as hand signals or two-way radios, to coordinate movements and operations when visibility is limited. - Secure loads properly with strapping or wrapping to prevent items from becoming dislodged during movement or redevelopment. - Position stored items securely on flat, stable surfaces to prevent them from rolling, slipping, or toppling over. - Regularly review and update safety procedures, taking into account any incidents or near misses, to continuously improve safety measures. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
