Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Ladder Set-up	Risky ladder placement, Unstable ground conditions, Faulty ladder condition	3H	<ul style="list-style-type: none"> - Conduct a pre-use inspection of the ladder to identify any damage or wear. - Ensure the ladder meets Australian safety standards and is rated for the intended load. - Position the ladder on a stable, level surface; use ladder levelers if necessary. - Secure the ladder base on surfaces that are firm, solid and not slippery. - Maintain a 1:4 ratio for the ladder angle; for every 4 meters of height, the base should be 1 meter away from the structure. - Avoid setting up ladders near doorways or high-traffic areas unless securing those areas from unintended access. - Keep a clear, clutter-free area around the base and top of the ladder. - Use a spotter or secondary person to hold the base when climbing whenever possible. - Verify weather conditions; avoid using ladders in windy or wet conditions which can cause instability. - Install non-slip safety feet on the ladder's base to prevent slipping. 	2M

Ladder Climbing	Risky climbing methods, Lack of safety gear	3H	<ul style="list-style-type: none"> - Ensure ladders are set up on stable, even ground to prevent tipping or slipping. - Conduct a pre-use inspection of the ladder for any visible defects or damage. - Use ladders that meet Australian standards AS/NZS 1892 to ensure structural integrity and safety compliance. - Limit the load carried on the ladder to what can be safely controlled with one hand while maintaining three points of contact. - Set the ladder angle between 70 and 75 degrees relative to the ground for stability. - Ensure workers maintain three points of contact at all times when climbing or descending ladders. - Avoid using metal ladders near electrical hazards to reduce risk of electric shock; use non-conductive ladders instead. - Secure the top of the ladder to a solid structure to prevent movement while in use. - Wear appropriate non-slip, supportive footwear to minimise the risk of slipping while climbing. - Prohibit the use of the top two rungs of the ladder unless specified otherwise by the ladder manufacturer for platform ladders. - Provide training for all workers on safe ladder usage, including proper climb and descent techniques. - Limit the time spent on ladders to reduce fatigue; encourage breaks and task rotation as needed. - Use fall protection equipment such as harnesses and lanyards where feasible, especially for higher elevations. - Ensure appropriate warning signage is posted to alert others in the area of ladder use and potential overhead work. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
