ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips or falls from height, Being struck by moving objects	3H	<ul style="list-style-type: none"> - Conduct a pre-start briefing to ensure all workers are aware of potential hazards and control measures. - Ensure all operators have undergone proper training and hold the necessary qualifications for straddle carrier operation. - Perform routine inspections of the work area to identify and remove any tripping hazards or obstacles near access points. - Use slip-resistant footwear to minimise the risk of slipping when accessing or exiting the straddle carrier. - Install guardrails or handrails on steps or elevated areas where practical to prevent falls. - Maintain communication with spotters to be aware of moving objects or nearby activity that could present a hazard. - Implement a traffic management plan to control pedestrian and vehicle movements around the operational area. - Ensure all safety signage is clearly visible and correctly positioned to alert workers to potential risks. - Keep walkways and access platforms clear of clutter, debris, and other materials that might cause trips. - Regularly inspect and maintain climbing aids such as ladders or staircases used to access the cabin of the carrier. - Establish an exclusion zone around the operating straddle carrier to prevent unauthorised personnel from entering danger areas. 	2M

Pre-Operation Inspection	Working near electricity, Exposure to hazardous substances	3H	<ul style="list-style-type: none"> - Ensure all operators have completed relevant training and hold valid certifications specific to operating straddle carriers. - Conduct a thorough inspection of the carrier before operation, checking brakes, steering, alarm systems, and emergency stop functions. - Use insulated tools and wear appropriate personal protective equipment (PPE) suitable for electrical safety when working near electricity. - Establish and maintain exclusion zones around power lines, ensuring all parts of the straddle carrier remain outside the safe approach distance. - Implement grounding procedures to prevent electrical shocks, especially in wet conditions or where contact with electric supply sources is possible. - Store hazardous substances like oils, fuels, and lubricants in labelled containers away from ignition sources, and ensure Material Safety Data Sheets (MSDS) are available and understood by the team. - Wear appropriate respiratory protection when inspecting areas treated with hazardous chemicals to minimise inhalation risks. - Regularly inspect and maintain all cables and connectors for signs of wear or damage to prevent electrical hazards. 	2M

Mounting the Straddle Carrier	Falls from height, Contact with high temperature surfaces		<ul style="list-style-type: none"> - Conduct a pre-operation check to ensure all access ladders and steps are in good condition and free from any defects. - Use purpose-built platforms or scaffolding with non-slip surfaces for safe access to the straddle carrier if required. - Ensure operators and personnel wear appropriate personal protective equipment, including high-visibility clothing, gloves, and steel-capped boots with non-slip soles. - Install handrails or guardrails on platforms and access points to provide support while mounting and dismounting the straddle carrier. - Implement a buddy system where another worker assists or supervises the operator during mounting to ensure safety procedures are followed. - Regularly train employees on safe mounting and dismounting techniques, focusing on maintaining three points of contact at all times. - Clearly mark and keep designated paths and access routes clear of obstructions, lubricants, and debris to prevent slips and trips. - Place signage around high-temperature areas warning against contact and indicating hot zones to avoid accidental burns. - Install insulating shields or covers over high-temperature surfaces where feasible to minimise the risk of contact. - Require workers to conduct mounted operations only when necessary and to minimise time spent on elevated platforms to reduce fall risks. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
