### ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

**Notes on Hierarchy of Controls:** Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Sling Selection	Incorrect sling for load exceeding working load limit (WLL)		<ul style="list-style-type: none"> <li>- Ensure that all synthetic slings used on site comply with Australian Standards AS 1353.1 for flat synthetic webbing slings and AS 4429 for round slings.</li> <li>- Conduct thorough training for all workers on the proper selection and inspection of synthetic slings, including understanding the working load limit (WLL) and the importance of sling angle in the calculation of actual load.</li> <li>- Utilise a selection guide or load chart specifically developed for synthetic sling usage that includes parameters like weight, configuration, balance, and surface condition of the load.</li> <li>- Implement a checklist, verified by a competent person, to confirm the correct type of sling is selected prior to use. This list should include factors such as load shape, size, weight, and rigging technique.</li> <li>- Maintain a sling registry log that records each sling's identification, WLL, inspection dates, damage reports, and maintenance history.</li> <li>- Perform pre-use checks to identify any signs of wear, tear, deformation, or chemical damage on the synthetic slings. Any defective or damaged slings must be immediately removed from service.</li> <li>- Ensure that operators know not to exceed the marked WLL on the sling, which includes considering factors like sling angles, which can significantly affect the effective capacity.</li> <li>- Provide adequate supervision on site to monitor and ensure proper handling and usage of synthetic slings, especially during selection and installation stages.</li> <li>- Develop and enforce a policy for periodic reviews and updates of all materials related to handling guidelines, particularly sling selection strategies, to align with new safety standards or improved operation procedures.</li> <li>- Place easy-to-read, durable tags on each sling detailing essential information such as type, WLL, manufacture date, and fibre material to prevent misuse.</li> <li>- Insist on simulation or practice sessions in controlled environments for workers to get familiarised with different loads and sling settings before actual operations commence to ensure confidence and correct sling selection under various conditions.</li> </ul>	1L

## SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

**The SWMS must be reviewed regularly** to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

**The SWMS must be monitored regularly** for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
