Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Falling object risks, noise exposure	3H	<ul style="list-style-type: none"> - Conduct a comprehensive site assessment to identify potential falling object hazards and develop an appropriate risk management plan. - Implement exclusion zones around areas where objects are likely to fall, using barriers or signage to restrict access by unauthorised personnel. - Equip workers with personal protective equipment (PPE) such as hard hats and high-visibility clothing to mitigate the risk of injury from falling objects. - Arrange for regular tool and equipment checks to ensure they are securely fastened or stored to prevent accidental dislodgement. - Develop and enforce strict work procedures for handling tools and materials at heights, emphasising secure placement and storage. - Install safety nets or catch platforms beneath work areas prone to dropping tools or debris, reducing the distance objects can fall. - Use spotters or lookouts to maintain visual awareness of overhead activities and communicate potential risks promptly to the work team. - Schedule regular noise monitoring and assessments to determine areas of high-risk exposure and ensure compliance with workplace standards. - Provide hearing protection such as earplugs or earmuffs to all personnel working in high-noise environments, adopting a mandatory usage policy. - Limit the duration of exposure to loud activities through job rotation or scheduling quieter tasks during peak noise periods. - Implement noise reduction measures, such as installing sound barriers or muffling devices on noisy equipment, to minimise ambient noise. - Train workers on the importance of adhering to noise control measures and the correct use and maintenance of personal hearing protection. 	2M

Equipment Installation	Electrical hazards, musculoskeletal injuries	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment before any equipment installation to identify potential electrical hazards and musculoskeletal injury risks. - Provide adequate training for all workers on the specific equipment being installed, with a focus on safe handling techniques and recognising electrical hazards. - Use insulated tools and PPE, such as gloves and boots, to protect against electrical shocks while working near live electrical components. - Ensure all electrical installations comply with Australian Standards and are performed by qualified electricians. - Implement lockout/tagout procedures to ensure machines are properly shut off and not started up again before the installation is complete. - Utilise mechanical aids such as hoists or dollies to help move heavy equipment, reducing the strain on workers' musculoskeletal systems. - Set up equipment in ergonomically favourable positions to minimise awkward postures and repetitive movements for installers. - Employ a buddy system, where two or more workers collaborate during installation tasks to share loads and assist each other, thereby reducing individual physical strain. - Clearly label all electrical hazards and ensure warning signs are visible and maintained in work areas. - Regularly inspect electrical equipment and cables for signs of wear or damage to prevent unforeseen electrical accidents. - Establish emergency response procedures, including access to first aid kits and trained responders, in case of incidents involving electrical shock or strain injuries. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
