Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Improper lifting, Tripping over materials	2M	<ul style="list-style-type: none"> - Use mechanical aids or team lifting techniques when handling heavy tiles to prevent improper lifting. - Provide manual handling training to workers to ensure safe lifting practices are followed. - Arrange tile delivery as close as possible to the work area to minimise the distance for lifting and carrying. - Keep the work area organised by stacking materials properly and securely to prevent tripping hazards. - Conduct a pre-work inspection to identify potential trip hazards and remove unnecessary materials from the work area. - Use appropriate personal protective equipment, such as gloves and steel-capped boots, to enhance grip and foot protection. - Clear mark walkways with tape or barriers to guide workers around the material storage areas. - Implement a housekeeping schedule to ensure regular removal of debris and an uncluttered workspace. - Designate specific storage areas for tools and equipment to keep them out of walking paths and prevent tripping. - Communicate regularly with the team about maintaining tidy workspaces and promptly addressing any identified hazards. 	1L
2. Mixing Adhesive	Skin irritation from cement, Dust inhalation	2M	<ul style="list-style-type: none"> - Conduct thorough training sessions on safe handling and mixing procedures for all workers before starting the task. - Require workers to wear appropriate personal protective equipment (PPE), including gloves, long-sleeved shirts, and full-length pants, to prevent skin contact with the adhesive. - Use dust masks or respirators approved by Australian standards to protect against inhaling fine dust particles during the mixing process. - Utilise a well-ventilated mixing area, preferably outdoors, to minimise dust accumulation in enclosed spaces. - Implement a no-touch policy for bare hands when handling cement bags; use tools to open and pour bags instead. - Provide readily accessible eye wash stations and safety showers near the work site in case of accidental exposure. - Equip mixers with dust extraction systems to capture dust at the source during the mixing process. - Minimise the amount of dry material used at any one time to reduce dust levels in the air. - Encourage regular breaks and rotating tasks among workers to limit exposure duration to potential irritants. - Post clear signage and hazard warnings in areas where adhesive mixing takes place. 	1L

Applying Adhesive	Eye injury from dust/grit, Strain from bending	2M	<ul style="list-style-type: none"> - Use safety goggles to protect eyes from dust, dirt and grit during adhesive application. - Implement proper ventilation systems to reduce airborne dust levels in the work area. - Ensure all workers are trained in the safe handling and application of tile adhesive. - Utilise long-handled tools for adhesive application to minimise the need for bending. - Encourage frequent breaks to allow workers to rest and stretch, reducing strain risk. - Provide knee pads for workers required to kneel while applying adhesive on floors. - Establish a cleaning schedule to keep the work area free from excess dust and debris. - Ensure adhesive products have clear labels and Safety Data Sheets (SDS) available onsite. - Position materials at an ergonomic height to reduce awkward bending movements. - Advise workers to alternate tasks to prevent repetitive strain injuries. - Introduce a buddy system to assist with heavy lifting and repositioning when required. - Conduct regular safety briefings to reinforce awareness of potential hazards and controls. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
