Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Crane Selection	Wrong equipment, equipment failure	3H	<ul style="list-style-type: none"> - Conduct a thorough risk assessment to identify the specific requirements of the job site and crane assembly/dismantling process. - Choose a crane with the appropriate load capacity to handle the specific weights and dimensions of tower crane components. - Verify that the selected crane has undergone recent inspection and maintenance checks, ensuring all safety features are operational and up to date. - Ensure the crane is equipped with adequate counterweights to maintain stability during lifting operations. - Check ground conditions where the crane will be set up to ensure it is level, stable, and capable of supporting the crane's weight. - Select a crane that has the necessary reach and height capabilities to safely and efficiently assemble or dismantle the tower crane within the site's constraints. - Confirm that all personnel involved in the crane operation are trained and competent, holding the necessary certifications to operate the equipment safely. - Ensure that the crane is fitted with boom and jib limit devices and load moment indicators to prevent overloading and other unsafe conditions. - Review weather conditions prior to starting work; postpone operations if extreme weather could compromise safe lifting. - Make sure communication systems between the crane operator and signal person(s) are clear, reliable, and established before beginning operations. - Plan and instruct on emergency procedures in case of equipment failure, ensuring prompt response to minimize risks and injuries. - Keep a detailed log of inspections, checks, and any maintenance performed on the crane to ensure transparency and traceability. - Evaluate the crane's operating manual and safety guidelines specific to the make and model being used to ensure compliance with manufacturer's recommendations. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
