Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Ensure they are clearly visible to drivers at all times. - Set up appropriate warning signs and barriers well in advance of the work zone to alert drivers of upcoming changes in the traffic conditions. - Utilise traffic cones, bollards, or delineators to create clear demarcation lines for vehicle pathways, and ensure that these guidelines are reflective for visibility during low light conditions. - Implement a communication protocol using two-way radios or hand signals to ensure that all staff can effectively communicate with one another, particularly in the event of an emergency. - Schedule regular breaks for traffic control workers to reduce fatigue-related risks and maintain a high level of alertness while managing traffic flow. - Monitor weather conditions and adjust the Traffic Management Plan accordingly to accommodate for reduced visibility or altered road conditions due to wet or inclement weather. - In case of an accident or emergency, have a clearly defined incident response procedure in place, which should include first-aid measures and how to quickly secure the area. - Regularly review and update the Traffic Management Plan and the associated Safe Work Method Statement (SWMS) to reflect any changes in the worksite conditions, legislation, or operational practices. 	2M

Ensure they are clearly marked and where possible, removed or repaired before work commences. - Provide all traffic controllers with a site-specific induction that includes familiarisation with the layout of the environment, access points, and emergency exits. - Create and distribute detailed site maps that highlight potential hazards, safe walking paths, and designated work zones to enhance on-site knowledge for all personnel. - Implement a buddy system where experienced staff accompany new workers or those unfamiliar with the site to provide guidance on potential risk areas. - Ensure that all traffic control personnel wear non-slip, high-visibility footwear suitable for the terrain to prevent slip and trip incidents. 	1L

			<ul style="list-style-type: none"> - Set up barriers or utilise warning signs around identified trip hazards if they cannot be immediately rectified, to alert workers and the public. - Arrange for adequate lighting in work areas and pathways, especially if working during early morning, evening, or at night, to ensure good visibility and to mitigate trip hazards. - Deliver regular toolbox talks focusing on situational awareness, emphasizing the importance of remaining vigilant for changing conditions and potential hazards throughout the day. - Develop a checklist for traffic controllers to use during their shift to continuously assess and manage any newly arising trip hazards or changes. - Provide clear communication channels, such as two-way radios or mobile phones, to report and respond swiftly to any hazardous situations that arise. - Install signage at the entrance and throughout the worksite, advising of ongoing traffic control operations and cautioning against identified trip hazards. - Regularly review the effectiveness of these control measures with the team, encouraging feedback and updating from those actively managing and experiencing the workplace environment, leading to continuous improvement in health and safety processes. 	
3.Set up Traffic Management Plan	Inaccurate plan, Miscommunication	3H	<p>Ensure a comprehensive traffic management plan (TMP) is developed, outlining every aspect of the proposed traffic control measures, including placement of signs and devices, safe pedestrian management, and emergency access. The plan should be tailored to the specific site and conditions and compliant with the latest version of Australian Standard AS 1742.3 - Manual of uniform traffic control devices, Traffic control for works on roads.</p> <ul style="list-style-type: none"> - Provide all team members involved in setting up the traffic management plan with detailed briefings and regular toolbox talks to ensure everyone clearly understands their responsibilities and the TMP specifics. - Designate a competent person as the traffic controller with appropriate certifications, such as training completed through the RIIWHS205D - Control traffic with a stop/slow bat or equivalent course, to oversee implementation of the TMP on-site. - Conduct a site-specific risk assessment before implementing the TMP, involving all stakeholders, including supervisors, workers, and local authorities if necessary, to identify unique potential hazards. - Utilise clear, unambiguous signage and communication devices conforming to Australian Standards to signal changes in normal traffic patterns and notify drivers well in advance of the worksite presence. - Establish a fail-safe communication system using radios or other electronic devices to maintain contact between all team members involved in the traffic management process. This ensures real-time communication in the event of an emergency or change in conditions. - Have detailed contingency plans ready for unexpected situations such as vehicle breakdowns, extreme weather conditions, or incidents within the work zone, accompanied by regular drills to ensure readiness. - Require that all changes to the TMP, no matter how minor they seem, go through a formal review process that includes a safety analysis before being approved and communicated to all relevant parties. - Keep a meticulous record of the TMP development process, including who was involved, when communications were made, modifications to plans, and any incidents that occur, to aid in post-implementation reviews and continual improvement processes. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
