Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Loading	Falling objects; manual handling injuries	3H	<ul style="list-style-type: none"> - Ensure all workers involved in loading are trained in manual handling techniques to reduce the risk of injury. - Use mechanical lifting aids such as forklifts or pallet jacks wherever possible to reduce manual handling. - Conduct a pre-loading inspection of the refrigeration units to check for secure packaging and any signs of damage. - Implement a buddy system where two or more workers are assigned to handle heavier or awkward loads together. - Establish exclusion zones around the loading area to prevent unauthorised personnel from entering and being struck by falling objects. - Utilise edge protection or barriers on loading ramps to prevent items from falling off during loading. - Use appropriate personal protective equipment (PPE) such as safety boots, gloves, and high-visibility clothing for added protection. - Position the load close to the worker's body to minimise strain and maintain a stable position while lifting. 	2M

Securing Load	Inadequate securing of load	4H	<ul style="list-style-type: none"> - Use appropriate tie-down points such as straps and chains rated for the weight and size of the refrigeration unit. - Conduct regular inspections and maintenance of all securing equipment to ensure they are in good condition. - Train team on correct loading and securing techniques to minimise the risk of load movement during transit. - Ensure the vehicle used for transportation has a flat, stable surface and is suitable for carrying heavy loads. - Distribute the weight of the load evenly across the vehicle to prevent tipping or instability. - Clearly label the centre of gravity on each refrigeration unit and position it correctly for optimal balance. - Make use of rubber mats or friction-enhancing materials under the refrigeration units to prevent sliding. - Implement a double-check system where a second person verifies that the load is secured properly before departure. - Limit the height of the load to maintain a low centre of gravity and lessen wind resistance. - Avoid overloading the vehicle according to its maximum load capacity specified by the manufacturer. - Secure smaller parts or accessories separately to prevent them from causing damage or becoming dislodged. - Instruct drivers on safe driving practices such as taking corners slowly and avoiding sudden stops. - Install monitoring systems like cameras or sensors to check the load's stability periodically during transport. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
