ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Trip hazards, Falling objects	2M	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify and clear any potential trip hazards before work begins. - Ensure that all personnel wear appropriate personal protective equipment, including non-slip footwear and hard hats. - Clearly mark and barricade the work area to prevent unauthorized access and reduce the risk of falling objects striking people below. - Use proper signage to alert workers and others in the vicinity about overhead work and potential hazards. - Secure all tools and materials not in immediate use to prevent them from being accidentally knocked off the roof edge. - Implement a housekeeping policy to ensure that waste materials and debris are regularly cleared from the work area. - Utilize safety harness and anchor points for all workers operating near the roof edge to mitigate fall risks. - Establish and communicate designated pathways for moving tools and materials to minimize clutter and trip hazards. - Train all workers on hazard identification and safe work practices specific to traversing along roof edges. - Assign a spotter or safety observer to monitor work activities and ensure adherence to safety protocols. - Ensure equipment and tools are maintained in good condition, with regular inspections conducted to prevent failures that could lead to falling objects. - Pre-plan material transport routes and methods to avoid carrying heavy or unwieldy items close to the roof edge. - Double-check weather forecasts and postpone work during adverse conditions like high winds or rain which could increase risks associated with working at heights. - Employ tool lanyards or tie-off systems to secure tools when working near roof edges, preventing them from becoming falling hazards. 	1L

Harness Fitting	Improper fitting, Broken or worn equipment	3H	<ul style="list-style-type: none"> - Conduct a pre-work check on all harness equipment to ensure there are no visible signs of damage or wear that could lead to breakage. - Ensure that the harness is compliant with Australian Standards (AS/NZS 1891.1 for industrial fall-arrest systems and devices). - Provide thorough training for all workers in correctly fitting and adjusting their harness to minimise risks associated with improper fitting. - Ensure that every worker checks their own harness fit, as well as undergoes a check by a trained supervisor or team leader before starting work. - Implement a buddy system, where workers inspect each other's harness fittings to identify any mistakes that might have been overlooked. - Ensure that the anchor points being used for harness attachment meet safety standards and can support the required load. - Regularly schedule inspections and maintenance of harness equipment by a qualified professional to prevent unexpected equipment failure. - Clearly mark and regularly inspect designated paths along roof edges to prevent unnecessary time spent near at-risk areas, reducing reliance on harness systems. - Use adjustable harness features to ensure that the fit remains snug and secure throughout the job to prevent shifting or loosening. - Set up and display instructional signage at access points reminding workers of correct harness procedures and potential hazards. - Establish emergency response procedures specifically related to harness equipment failure or improper use, ensuring workers are familiar with these steps. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
