ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slips, trips and falls, Exposure to dust, Electric shock	3H	<ul style="list-style-type: none"> - Ensure the work area is clean and free from debris to prevent slips, trips, and falls. - Use a dust extraction system or vacuum with a HEPA filter to minimise dust exposure during drywall trimming tasks. - All electrical tools and equipment should be tested and tagged according to Australian standards to prevent electric shock. - Wear appropriate Personal Protective Equipment (PPE), such as non-slip footwear, safety glasses, dust masks, and gloves while performing tasks. - Place warning signs and barriers around the work area to alert others to potential hazards. - Use cordless power tools where possible to eliminate tripping hazards from cords. - Secure all electrical cords and hoses away from pathways to prevent tripping incidents. - Provide adequate ventilation in the working area to disperse dust and airborne particles. - Implement a regular maintenance schedule for all electrical tools and equipment to ensure they are in safe working condition. - Train workers in safe lifting techniques and correct posture to prevent manual handling injuries. - Conduct a risk assessment before starting work to identify any additional site-specific hazards and implement control measures accordingly. - Ensure a first aid kit is readily available on-site and that workers have access to trained first-aid personnel. 	1L

Inspection of Work Area	Falling objects, Inadequate lighting	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss the potential for falling objects and ensure everyone is aware of the dangers. - Securely store tools and materials on stable surfaces away from edges to prevent them from falling. - Use toe boards or mesh panels on scaffolding and elevated work areas to contain materials and tools. - Implement exclusion zones marked with barriers or cones around areas where work is being performed overhead. - Require all personnel in the vicinity to wear hard hats approved per Australian safety standards to protect against impact injuries. - Ensure adequate lighting by using portable lights, especially in areas where natural light is insufficient. - Inspect all lighting equipment before use to confirm it is in good working order and positioned correctly. - Provide additional task lighting to illuminate specific work areas where details are critical, reducing shadowing and contrast that could hide hazards. - Encourage workers to report any areas with inadequate lighting so adjustments can be made promptly. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
