Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Equipment Set-up	Electric shock, Uneven ground hazards	2M	<ul style="list-style-type: none"> - Conduct a pre-work site assessment to identify any uneven ground and level the area as much as possible using portable ground leveling devices or temporary platforms. - Use insulated tools and equipment specifically designed for working around power lines to reduce the risk of electric shock. - Ensure all equipment, including ladders and lifts, have proper grounding and are kept at a safe distance from power lines as per Australian safety standards. - Set up safety barriers or warning signs around the work area to keep unauthorized personnel away and reduce tripping hazards on uneven ground. - Implement a buddy system where one team member is designated as the spotter to monitor distance from power lines and guide equipment operators. - Utilize personal protective equipment (PPE), including rubber gloves and insulated boots, to provide an additional layer of protection against electric shock. - Follow strict adherence to lockout/tagout procedures to ensure no electrical supply is active in the nearby power lines during limb trimming activities. - Conduct comprehensive training sessions for all workers on the risks associated with trimming limbs near power lines and the importance of maintaining secure footing on uneven terrain. - Maintain clear communication between team members using two-way radios or hand signals to prevent misunderstandings that could lead to accidental contact with power lines. - Deploy stabilising outriggers on lifts and elevated work platforms to improve stability on uneven surfaces. - Continuously monitor weather conditions, such as wind or rain, which could worsen footing on uneven ground and increase the risk of electric shock. - Develop an emergency response plan specific to potential incidents involving electric shock or slips and trips, ensuring all staff understand their roles and responsibilities. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
