The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Use wheel chocks to prevent any vehicle movement during the unhooking process, ensuring stability. Select a level surface for performing the unhooking task to further minimise the risk of vehicle instability. Instruct all personnel to keep a safe distance from both vehicles during the unhooking procedure to avoid the risk of injury from unexpected movements. Clearly communicate with all involved parties regarding the sequence of tasks and signals to be used, reducing the risk of miscommunication that might cause mistakes leading to instability. Use a spotter where necessary to guide the driver and monitor the situation, providing an extra layer of safety by monitoring both the ground and vehicle conditions. Ensure adequate lighting if working in low-visibility conditions to help workers better assess the site for potential hazards. 	1L

SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

- 2. Consultation with workers, contractors and sub-contractors.
- 3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
