ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Trip hazards, Skin contact with chemicals	2M	- Conduct a site inspection to identify and mark any potential trip hazards in the workspace prior to commencing operations. - Keep all walkways and work areas clear of clutter and ensure proper storage of tools and materials. - Use appropriate signage to clearly indicate zones prone to tripping, especially around uneven surfaces or steps. - Provide training for workers on maintaining a tidy work environment and reporting any identified trip hazards immediately. - Implement a regular housekeeping schedule to ensure that the workspace remains clean and organised. - Use spill containment kits and absorbent materials to promptly clean up any liquid spills that may cause slips or trips. - Require personal protective equipment (PPE) like gloves, goggles, and aprons for handling chemicals to prevent skin contact. - Ensure that safety data sheets (SDS) for all chemicals used are accessible and workers are trained in their use and hazards. - Install proper ventilation systems to minimise exposure to harmful chemical vapours, reducing skin and respiratory risks. - Use non-slip mats or coatings in areas where liquid chemicals are frequently used to prevent slips and subsequent skin contact.	1L

Design Consultation	Eye strain, Incorrect posture	2M	- Ensure adequate lighting in the workspace to reduce eye strain. - Position computer monitors at eye level and approximately an arm's length away from the eyes. - Implement regular breaks or micro-breaks from screen time every 20 minutes for 2 minutes to rest eyes and prevent strain. - Provide adjustable chairs with proper lumbar support to maintain correct posture. - Encourage the use of ergonomic desks that can be adjusted for sitting or standing positions. - Organise workstations to minimise awkward reaches, ensuring frequently used items are within easy reach. - Use blue light filter screens or software on computers to reduce eye fatigue. - Conduct ergonomic assessments of individual workstations to tailor solutions specific to each worker. - Educate employees on good posture practices and the importance of maintaining neutral body positions. - Provide footrests for those whose feet do not comfortably reach the floor while seated. - Implement stretching exercises or wellness programs that focus on neck, back, and shoulder tension relief.	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review process should be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
