Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Manual handling injuries, tripping on equipment	2M	<ul style="list-style-type: none"> - Conduct a manual handling risk assessment to identify potential risks and implement appropriate control measures. - Ensure all workers involved have completed manual handling training specific to use of a jack. - Use mechanical aids such as trolleys or dollies to transport the jack to the work area, reducing the need for lifting. - Establish a clear path from obstacles or clutter for transporting the jack to minimise tripping hazards. - Store tools and equipment in designated areas to prevent them from becoming tripping hazards in the work area. - Implement team lifting techniques if a mechanical aid cannot be used; ensure adequate personnel are available to lift safely. - Position the jack on a stable, level surface to avoid instability that could lead to falls or trips. - Mark uneven surfaces or changes in floor level with high-visibility tape to alert workers to potential trip hazards. - Wear appropriate personal protective equipment (PPE) such as steel-capped boots to protect feet from dropped objects. - Organise the workspace efficiently to ensure that all necessary materials are within easy reach, reducing the need for unnecessary movement. - Regularly inspect and maintain the jack and surrounding area for any potential hazards before commencing work. 	1L

Position Jack	Struck by vehicle, Slip and trips	2M	<ul style="list-style-type: none"> - Ensure the vehicle is on a stable, level surface before positioning the jack to prevent the risk of it moving unexpectedly. - Engage the vehicle's handbrake and place wheel chocks around the wheels not being lifted to secure the vehicle in place. - Conduct a visual inspection to identify potential slip or trip hazards around the working area and clear any debris before work. - Verify that the jack is rated for the weight of the vehicle to avoid equipment failure or instability. - Position the jack at specified lifting points on the vehicle as indicated in the vehicle manufacturer's manual to prevent damage to the vehicle or injury. - Use appropriate personal protective equipment (PPE), such as gloves and steel-toed boots, to minimise the risk of injury while handling heavy equipment. - Maintain clear communication with all personnel involved, ensuring they are aware of the process and their role in maintaining safety. - Keep a safe distance from the vehicle while positioning the jack, ensuring no body parts are underneath the vehicle at any time. - Assign a qualified person to oversee the task, ensuring all steps are followed correctly and intervening if practices are unsafe. - Ensure adequate lighting in the work area to clearly see and accurately position the jack without straining. - Do not rush the process; take the necessary time to ensure correct jack placement and stability before starting any work under the vehicle. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
