Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Inspection of Equipment	Faulty equipment, Incorrect handling	3H	<ul style="list-style-type: none"> - Conduct a thorough visual inspection of the block and tackle equipment before each use to check for any signs of damage or wear. - Use only equipment that is certified and compliant with Australian Standards specific to the task and load requirements. - Verify that all parts, including ropes, pulleys, hooks, and shackles, are free from corrosion and other visible defects. - Ensure that the working load limit (WLL) is clearly marked on the equipment and is suitable for the intended application. - Never use equipment that has been modified or repaired without proper re-certification by a qualified professional. - Implement a system where defects or faults identified during inspections are reported immediately and the equipment tagged out of service until rectified. 	2M

Setting Up Block and Tackle	Incorrect rigging, Falling objects	3H	<ul style="list-style-type: none"> - Conduct a pre-use inspection of all block and tackle equipment for signs of wear, damage, or defects. - Ensure that the rigging plan is reviewed and approved by a qualified person before installation. - Use appropriately rated and certified block and tackle equipment suitable for the load's weight. - Follow manufacturer instructions for correct assembly and use of block and tackle to prevent incorrect rigging. - Secure the anchorage points on solid, stable structures capable of supporting intended loads. - Train personnel in proper rigging techniques and safe lifting practices specific to block and tackle systems. - Maintain a clear area around the setup and operation zones to minimise risk of falling objects impacting people. - Employ taglines on loads to guide their movement and maintain control during lifting operations. - Display warning signs and barriers to keep unauthorised personnel away from work areas. - Attach secondary securing devices like safety lanyards to critical points to arrest falls of unsupported parts. - Use personal protective equipment such as helmets with chin straps, safety boots, and gloves while setting up the equipment. - Implement a communication plan with signals or radios to ensure all team members are aware of actions and hazards. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
