Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Tripping over equipment, Burns from hot water	3H	<ul style="list-style-type: none"> - Conduct a pre-start meeting to discuss safety procedures and ensure all workers understand the risks involved. - Clearly mark and delineate the work area with barriers or cones to prevent unauthorised access and minimise trip hazards. - Ensure all equipment, hoses and cables are neatly arranged to avoid potential tripping hazards. - Check the work area for any obstacles or debris that could pose tripping risks and clear them before starting. - Wear appropriate personal protective equipment (PPE), including heat-resistant gloves, long-sleeved clothing and non-slip boots. - Regularly inspect the hot water blaster for any signs of wear or damage before use. - Secure all connections on hoses and fittings to prevent leaks and reduce the risk of burns from hot water. - Use insulated tools and handles when handling parts of the equipment that may become hot during operation. - Assign a spotter or lookout to monitor the work area for any emerging hazards and warn operators of potential dangers. - Display warning signs around the worksite to alert others of the presence of high-temperature operations. - Implement and communicate emergency procedures in case of an accident or injury, ensuring all workers know how to respond effectively. - Train workers in the safe operating procedures for hot water blasters, including the correct methods for startup and shutdown. - Limit access to the work area to trained personnel only to maintain a controlled environment. - Ensure adequate lighting is provided so workers can clearly see their surroundings and identify any hazards. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
