If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Conduct a pre-task assessment to determine the safest route for transporting the grill, avoiding uneven surfaces and obstacles where possible. Utilise team lifting procedures when moving heavy or large grills, ensuring that team members communicate effectively throughout the lift. Clearly mark and isolate transportation pathways to prevent unauthorised access by vehicles or pedestrians during the movement process. Wear appropriate personal protective equipment, including gloves with good grip and supportive footwear to enhance safety during lifting and carrying. Plan transportation during low traffic periods to reduce exposure to moving vehicles and associated traffic hazards. Engage a spotter where necessary to assist in navigating potential traffic and pedestrian risks. Secure the grill properly on the transport equipment to prevent shifting, tipping, or falling during movement. Verify the weight capacity of the transport aids and ensure it is not exceeded to avoid failure or accidents. SAFE WORK IN THE STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains a fective of must be reviewed (and revised if necessary) if relevant control measures are revised. The view process should be carried out in consultation with workers (including contractors of the SWMS and their health and safety representatives who represented that work group at the workplace.

When the SWMS has been revised the PCBU mast ensure that advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a rest of the review are advised of the changes in a way that will enable them to implement their duties and the involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.
