Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Exposure to hazardous materials, equipment malfunction	2M	<ul style="list-style-type: none"> - Ensure all workers are trained in hazardous material handling procedures and recognise potential risks associated with the equipment. - Conduct a thorough inspection of lifting equipment including hooks and chains, prior to use to confirm they are in good working condition and not damaged or worn. - Implement and adhere to scheduled maintenance and servicing programs for all lifting equipment to prevent unexpected failures. - Use appropriate personal protective equipment (PPE), such as gloves, safety glasses, and hard hats, when preparing to operate lifting equipment. - Develop and maintain current register of hazardous materials on site, and ensure proper labelling and storage according to regulations. - Establish communication plan that includes hand signals or radio communications to ensure clear instructions among team members involved in the lifting process. - Provide comprehensive induction and ongoing training sessions for all personnel involved in lifting operations to reinforce safety procedures and emergency protocols. - Establish exclusion zones around areas where lifting operations are taking place to prevent unauthorised access and minimise the risk to bystanders. - Verify that load limits for hooks, chains, and any other lifting gear are clearly marked and strictly adhered to prevent overloading and potential equipment failure. - Have an emergency response plan in place specific to lifting operations, ensuring immediate actions can be taken if an equipment malfunction occurs. - Regularly review and update safety procedures and control measures based on incident reports, near-misses, and industry best practices. - Equip lifting machinery with fail-safe mechanisms, such as automatic brakes or overload alarms, to reduce the likelihood of accidents caused by equipment malfunction. - Ensure that there is adequate lighting and visibility in the work area to help workers identify hazards promptly and ensure safe operation of lifting equipment. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
