ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

			<ul style="list-style-type: none"> - Conduct a pre-start safety check to ensure all guards and protective devices are in place and functioning properly. - Ensure all operators are trained in the safe operation of cutting equipment and are aware of the specific hazards associated with machine startup. - Use hearing protection, such as earplugs or earmuffs, to mitigate noise exposure for operators and nearby workers. - Implement a clear zone around the machinery to prevent unauthorised access during startup, marked with visible barriers or signs. - Undertake regular maintenance checks to reduce the risk of mechanical faults that may lead to excessive noise or unsafe operation. - Enforce the wearing of appropriate personal protective equipment (PPE) including flame-resistant clothing and eye protection to safeguard against spark emission. - Fit the machine with appropriate local exhaust ventilation systems to capture and remove emissions immediately at the source. - Install sound-dampening materials and barriers around the work area to minimise noise pollution affecting other work areas. - Utilise automatic or remote startup controls where possible to keep operators at a safe distance from potential hazards. - Establish emergency shut-off procedures that can be quickly activated in case of malfunction or excessive noise levels. - Position portable screens or shields strategically to protect adjacent areas and personnel from spark fallout. - Schedule high-noise activities at times that will minimise disturbance to other operations or personnel in the vicinity. - Provide regular training updates on changes in equipment operation standards and safety procedures to keep all personnel informed of best practices.

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
