ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Shut Down	Equipment failure, Stored energy release	4A	<ul style="list-style-type: none"> - Ensure all employees are trained in proper shutdown procedures and understand the risks of equipment failure and stored energy release. - Use lockout/tagout (LOTO) systems to ensure machinery is completely de-energised before performing maintenance or repair work. - Verify that all moving parts have stopped before beginning any shutdown operations. - Inspect the equipment for signs of wear or damage that could lead to malfunction during the shutdown process. - Follow manufacturer's instructions for shutdown procedures strictly to prevent premature equipment failure. - Prior to shutdown, communicate the intent to all workers in the vicinity to prevent unexpected restart attempts. - Use physical barriers to restrict access to the machinery area during shutdown to protect against accidental engagement. - Regularly maintain machinery to ensure hydraulic and pneumatic systems do not have excess pressure accumulations that can release unexpectedly. - Deactivate energy sources such as electricity, compressed air, and hydraulics, double-check their isolation, and relieve residual pressures. - Conduct a "zero energy state" verification check to confirm all potential energy sources have been effectively isolated. - Document shutdown procedures and update them regularly to incorporate any changes in equipment or operational practices. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
