ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

Preparation	Slips, trips and falls, improper lifting techniques	2M	<ul style="list-style-type: none"> - Conduct a site inspection to identify and clearly mark any potential trip hazards such as uneven surfaces or cluttered pathways. - Ensure the work area is well-lit so that all team members can see clearly and avoid tripping over obstacles or slippery surfaces. - Provide anti-slip mats or coverings in areas prone to wetness or spills to reduce the risk of slipping. - Instruct workers on house-keeping practices, such as keeping tools and materials organised and stored away from walkways. - Implement a manual handling training program to educate workers on safe lifting techniques to minimise risk of injury. - Encourage workers to use their legs rather than their back while lifting by bending at the knees, not the waist. - Encourage the use of mechanical aids such as trolleys or wheelbarrows for carrying heavy loads to reduce strain on the body. - Mandate the use of appropriate personal protective equipment (PPE), like non-slip footwear with good ankle support, to prevent slips and trips. - Set up barriers, cones, or caution tape around hazardous areas to prevent unauthorised access and warn employees of potential dangers. - Develop and enforce a clear communication plan using signals or radios between team members to coordinate activities safely and avoid accidents. 	1L

Select Tools	Incorrect tools for the job, trowel sharpness	2M	<ul style="list-style-type: none"> - Ensure all workers are trained in the proper selection and use of trowels for specific tasks. - Consult the project requirements or a supervisor to confirm the correct type of trowel needed for the job. - Use a tool checklist to verify that only correctly-sized and appropriate trowels are selected for the task. - Inspect each trowel for defects before use, checking for damaged handles and blades. - Keep an inventory of various trowel types and sizes to ensure availability of the right tool for different jobs. - Label trowel storage clearly to avoid confusion and ensure quick access to the correct tool. - Establish a maintenance schedule to regularly check and maintain the sharpness and condition of trowel blades. - Use protective gloves to minimise risk from sharp edges when handling or working with trowels. - Store trowels separately in designated slots or containers to prevent accidental contact with sharp edges. 	1L

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
