Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Notes on Hierarchy of Controls: Elimination methods are the most effective and preferred when controlling a hazard. Substitution is the second most effective method of controlling a hazard. Engineering by isolation is the third most effective, while Administrative Controls by changing the work is the fourth most effective method. PPE (Personal Protective Equipment) is the least effective method.

2. Equipment Setup	Electric shock, Equipment failure	3H	<ul style="list-style-type: none"> - Ensure all electrical equipment is tested and tagged by a qualified electrician in compliance with Australian standards. - Conduct a pre-use inspection of the vinyl cutter for any visible damage or wear, particularly checking electric cables and plugs. - Ensure that the power supply is aligned with the manufacturer's specifications of the vinyl cutter to prevent overload or faults. - Use insulated tools and equipment when setting up the vinyl cutter to reduce the risk of electric shock. - Establish a safe zone around the work area with clear signage to prevent unauthorised personnel from accessing during setup. - Make sure all safety guards are installed correctly and securely before starting the setup process. - Provide appropriate Personal Protective Equipment (PPE) such as rubber-soled shoes and gloves to minimise risk of electric shock. - Verify that all emergency stop buttons on the equipment are functional and accessible at all times. - Regularly schedule maintenance of the vinyl cutter according to manufacturer's recommendations to identify potential failures. - Use a Residual Current Device (RCD) or switchboard-installed circuit breakers to enhance electrical safety. - Train staff on recognising and reporting faulty equipment and unsafe conditions immediately. - Keep flammable materials away from the equipment to prevent fire risk in case of an electrical fault. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
