ALL PERSONNEL PARTICIPATING IN ANY ACTIVITY ON THIS SWMS MUST HAVE THE FOLLOWING COMMUNICATED

Safety meetings or toolbox talks will be scheduled in accordance with legislative requirements to first identify any site hazards, then to communicate those hazards and then to further take steps to either eliminate or control each hazard.

If an incident or a near miss occurs, all work must stop immediately. Depending on the severity of the incident, a meeting will be called with all workers to amend the SWMS if required. The meeting may also be an educational opportunity.

Any changes made to the SWMS after an incident or a near miss must be approved by the Person Conducting Business or Undertaking and communicated to all relevant personnel.

The SWMS must be kept and be available for inspection at least until the work is completed. Where a SWMS is revised, all versions should be kept. If a notifiable incident occurs in relation to which the SWMS relates, then the SWMS must be kept for at least two years from the occurrence of the notifiable incident.

Preparation	Slips, trips and falls, electrical shock	3H	<ul style="list-style-type: none"> - Conduct a thorough site inspection to identify any potential slip or trip hazards and remove or mark them. - Ensure the work area is well-lit to clearly see instructions or wet spots on the floor. - Use non-slip mats or coverings on particularly slippery surfaces to reduce the risk of slipping. - Keep work areas tidy by organising cables and hoses away from walkways and securing them with cable covers. - Provide training on safe work practices, including how to carry and use vacuum equipment safely. - Implement a policy for cleaning up spills immediately, using appropriate warning signage while the area is still wet. - Regularly check and maintain personal protective equipment (PPE), such as non-slip footwear, to ensure effectiveness. - Inspect electrical cords for damage before each use and ensure they are in good condition and appropriately rated. - Use only equipment that is suitable for the environment and compliant with the local electrical safety standards. - Implement a tagging system for damaged or faulty equipment to prevent their use until repaired or replaced. - Ensure power outlets are easily accessible and not overloaded with multiple plugs or adaptors. - Train workers on the location of circuit breakers and how to disconnect power promptly in an emergency. - Have a regular schedule for testing and tagging electrical equipment to comply with AS/NZS 3760 standards. 	2M

Setup	Lifting injuries, electrical shock		<ul style="list-style-type: none"> - Conduct a manual handling training session for all workers to ensure they use proper lifting techniques when picking up vacuum equipment. - Use dollies or lifting aids where possible to transport and position heavy vacuum equipment to reduce manual handling. - Assess the work area and plan the setup route to avoid obstacles and minimise unnecessary bending or twisting. - Implement a two-person lift for heavier components of the vacuum equipment to distribute the load more evenly and reduce the risk of injury. - Ensure that power cords and electrical connections are in good condition and not frayed or damaged to prevent electrical shock. - Use Residual Current Devices (RCDs) on electrical circuits as an additional safety measure against electrical faults during setup. - Clearly label and identify all power outlets and switches to ensure correct connection and disconnection of vacuum equipment. - Conduct a pre-use inspection of all equipment to ensure all electrical components, including plugs and cords, are in safe working order. - Ensure that all personnel involved in the setup are wearing appropriate PPE, such as gloves, to protect from potential electrical hazards. - Provide adequate lighting in the setup area to allow workers to clearly see all connections and potential hazards, reducing the risk of accidents. 	2M

SAFE WORK METHOD STATEMENT MONITORING AND REVIEW

The SWMS must be reviewed regularly to make sure it remains effective and must be reviewed (and revised if necessary) if relevant control measures are revised. The review must be carried out in consultation with workers (including contractors and sub-contractors) who may be affected by the operation of the SWMS and their health and safety representatives who represent that work group at the workplace.

When the SWMS has been revised the PCBU must ensure that all persons involved with the work are advised that a revision has been made and how they can access the revised SWMS, including all persons who will need to change a work procedure or system as a result of the review are advised of the changes in a way that will enable them to implement their duties consistently with the revised SWMS. All workers that will be involved in the work must be provided with the relevant information and instruction that will assist them to understand and implement the revised SWMS.

The SWMS must be monitored regularly for the effectiveness of ensuring hazard controls are effective in reducing the risk of incidents, keeping the workplace safe for all personnel. The person responsible for monitoring the effectiveness of the Safe Work Method Statement should employ a multi-faceted approach which includes but is not limited to:

1. Spot Checks.
2. Consultation with workers, contractors and sub-contractors.
3. Internal audits on a continual basis.

An approach of continuous improvement, promptly recording inconsistencies or deficiencies, followed up by immediate corrective action and consultation with all relevant personnel ensures that the PCBU is consistently developing ever-improving systems of safe work principles.
